<u>6. Proposed Reply to R-25-0035, Petition to Amend Rule 39(b)(12), Ariz. R. Sup. Ct.</u> – Scott Boncoskey

Scott Boncoskey, member of the Criminal Practice & Procedure Committee, presented to the Board a proposed reply to R-25-0035, Petition to Amend Rule 39(b)(12), Ariz. R. Sup. Ct. The Rules of Criminal Procedure, which pertains to the victim interview request process. The proposed reply defends the proposed rule change as a modest procedural reform aimed at enhancing fairness, transparency, and efficiency in how victim interview requests are handled. The reply refutes several criticisms raised in comments.

<u>10. Finance and Audit Committee</u> – Jessica Iennarella, Chris Russell Jessica presented a Q1 Update:

- Operating surplus of \$10K relative to a budgeted deficit of \$227K. Investment activity for the first quarter is a surplus of \$19K. Total change in net assets for Q1 2025 is \$29K surplus.
- Revenue totals \$5,069K for Q1. Annual fee collections are materially in line with budget.
- Expenses total \$5,059K for Q2. All expense categories (i.e. personnel, depreciation, operating) are within budget, albeit closer to budget then prior years.
- Start projections after Q2 when Convention has occurred.

11. Nominating Committee Update – Benjamin Taylor

Benjamin updated the Board on the progress of the nominating committee. The committee is convening on June 5th to conduct interviews and discuss nominations of the 2025 – 2026 Board members.

At Convention the nominating committee chair, Benjamin, with inform the Board and public of the selected candidates. Asking the candidates to present at the Board meeting, then vote.

12. BLI Update – Noah Coakley

Noah presented an update to the Board regarding the BLI (Bar Leadership Institution) program. This May, the 2025 Graduating Class of fifteen individuals. The application window opens June 2nd for the next program session, Noah encouraged the Board to invite mutuals or individuals to participate in the program.

Noah demonstrated the work the BLI program accomplished on their Instagram platform and website page within the State Bar of Arizona webpage. The BLI graduating class worked together to research and publish a historical timeline of the Bars organization. Noah also presented a few video clips that represent what BLI means, the initiative, what can be taken from it and earned, etc.

Noah looks forward to growing the BLI community, getting the public and people at the State Bar

more involved. Noah additionally plans to initiate a two-night retreat for the program to enhance the connections and networking of those participants with legal professionals.
