- CEO England informed the Board that the Arizona Supreme Court issued its decision on the Goldwater Petition. The Court modified Supreme Court Rule 32 to clarify that the State Bar's compliance with *Keller* extends beyond lobbying activities to include activities related to regulating the legal profession or improving the quality of legal services. The State Bar already applies *Keller* to its activities generally; therefore, we do not anticipate any significant changes to our operations.
- CEO England informed the Board that the State Bar's internal Employee Retention
  Workgroup recommend changes to the annual review process; new system and process will
  be rolled out to employees beginning in January of 2025.
