4. Construction Defect Law.

Attorney Bob Willis petitions the BLS to create a Construction Defect Law board certified specialty. He believes it will further the BLS mission as it takes above-average knowledge and experience to properly and efficiently resolve construction defect matters for clients, and a specialty will allow property owners and industry professionals to connect with a recognized qualified attorney that can successfully handle all disputes. The area is complex in that a single case will involve multiple parties, multiple issues, and can be on multiple tracks simultaneously with lots of moving parts and different people involved. Additionally, the area is governed by

specific statues, case law, rules, and terminology, and claims are resolved through all types of forums (state, federal and tribunal courts, administrative courts, and alternative dispute resolution processes) and quite often through a combination of those forums. In the Courts these cases fall under Complex Tier 2 or 3 categories, and knowledge of building codes, the Condominium Act, the Purchase Act, Planned Communities Act, and indemnity are imperative.
